Message from the Board President, 2007-2010

Community Link has been a part of the Davis family since 1978—when my brother, John, first enrolled. Over the past years, he has achieved breakthroughs in adult learning and living on his own, has found a good job that he enjoys, and has made long-term friends to expand his social circle beyond his family.

Our family has seen first-hand how John has grown to become happy and fulfilled at Community Link. That's why I agreed to serve on the Community Link Board of Directors. Later, I was selected as Board President for three fiscal years, ending June 30, 2010.

During those three years, we transitioned to a successor executive director. This past year, especially, we also focused on board development to improve our effectiveness and help lead the agency to an even higher standard of excellence. Together with the administrative staff, we facilitated the revitalization of a support group for program participants' family and friends. Fiscally, we survived ongoing state payment delays and the elimination of state funding for certain services; throughout that ongoing financial challenge, the United Way of Greater St. Louis provided us with stable funding, one-time grants, and numerous strategic resources. Dedicated staff found new and different funding sources—and enhanced life-skills programming “on a shoestring.” Meanwhile, community businesses, organizations and individuals stepped up to the plate with additional charitable contributions. This combined support made it possible for Community Link to serve 549 individuals—341 adults and 208 children—on an ongoing basis in the past fiscal year, plus hundreds more through case referrals, developmental screenings, and a dental clinic.

This Annual Report, for the fiscal year ended June 30, 2010, is full of interesting statistics. It's also filled with pictures and stories of people—like you and me—who are trying to better their lives

and give back to the community. As challenging as their lives might be, Community Link program participants always have the desire to help someone else!

So, after my father passed away, our family didn't hesitate on how to distribute some of the estate. We agreed we wanted to put up a marquee at Community Link's main building, so everyone who passed by on Old Route 50 would notice the good work being accomplished and would become more aware of ways to get involved.

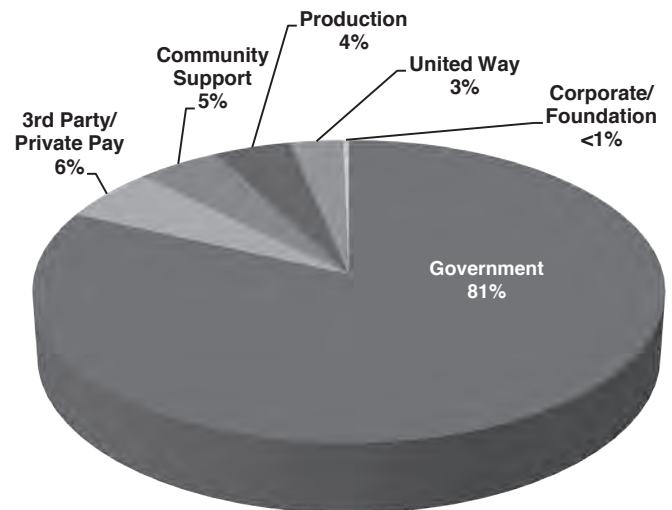

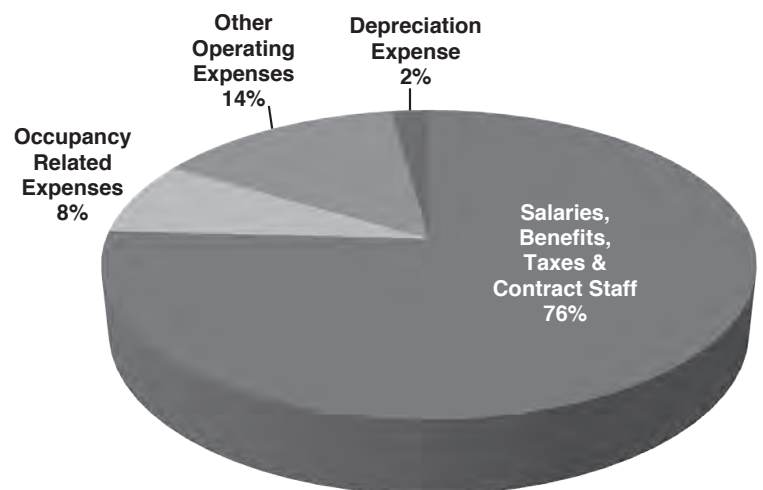

First Step helps families with kids 0-21 achieve breakthroughs



What a cute baby posing amid the pumpkins at Eckert's Orchards. First Step organized a family field trip there, so babies could experience shapes, colors, textures and aromas, and parents could learn how to plan low-cost, educational, fun family outings.



A First Step mom introduces her baby to apple-picking. Wise food choices and economical food sources are part of the First Step Early Head Start health-and-nutrition curriculum.



First Step encourages father involvement with an annual fishing derby at Carlyle Fish Hatchery, as well as trips to minor-league baseball.

First Step Early Learning & Family Support programs are designed to enhance the physical, social-emotional and intellectual development of children, to support parents' efforts to fulfill their crucial role as the child's first and best teacher, and to help families move toward school readiness and self-sufficiency. Families may be eligible for more than one of the programs: Early Intervention, which the Agency pioneered in Southern Illinois in 1978, and Children's Waiver case coordination, both funded by DHS; Early Head Start, federally funded for children pre-birth through age 3 from low-income and other at-risk families; Infant & Family Mental Health Services, and Happiest Baby classes, generously funded by United Way of Greater St. Louis, to enhance family bonding and coping skills for 50+ families this past year; and Prevention Services, which provided developmental screenings for 100+ children. EHS bolsters family literacy, health, nutrition

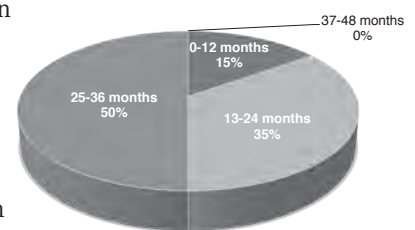
A Hispanic mom memorized a story in English so she could "read" the book to her baby, and in the process learned to read English herself. ... A junior high school girl learned to juggle school and parenting and graduated with high honors as a result of the support received. ... A single mom, once timid and insecure, attended a Head Start state conference, then shared helpful information with other families at the EHS parent-child play groups and Policy Council. ... A couple, who adopted a fragile child born to a drug-addicted mother, learned coping techniques and health-and-nutrition strategies. ... These are just some of the breakthroughs achieved by the 91 enrolled EHS clients this past year; some 50-plus children are enrolled at any one time. More than one-fifth—22 percent—of the enrolled families speak Spanish or are of Hispanic descent; they are assisted by a bilingual home visitor. Early Intervention identifies and resolves many issues

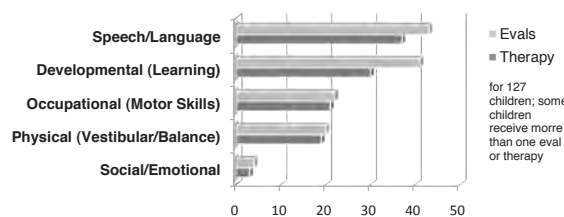
When 127 local children were evaluated this past year, therapists found 74 percent eligible for therapy. During the same year, 30 percent of the eligible children turned 3 years of age and moved on to other preschool programs, while 10 percent met all goals before age 3.

Moreover, all the families said the EI services helped them deal more effectively with the needs they identified—including coping with the social-emotional challenges that can affect the entire family system when a child faces special difficulties.

Early Intervention Services Provided FY 2009-10



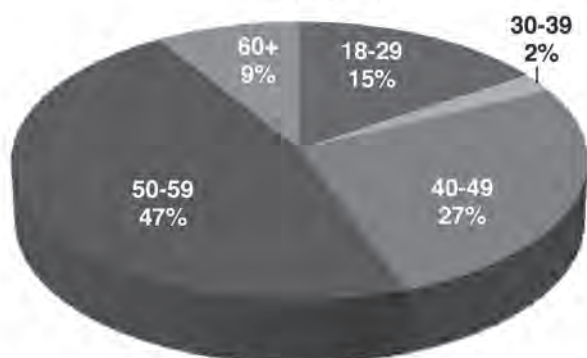

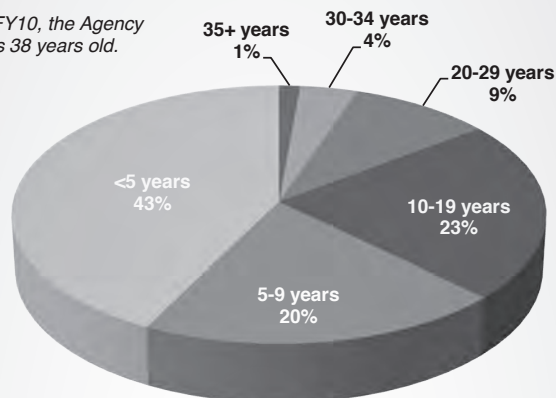

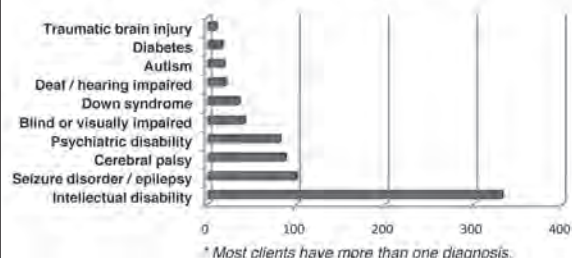

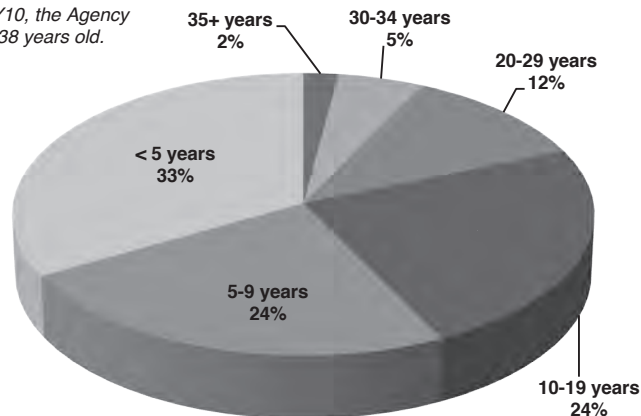

Community Link helped divert more than 275 tons of municipal waste from landfills in FY 2009-10. The Recycling Center collected 2.08 tons of aluminum, 12.02 tons of plastic, 4.1 tons of white copy paper, 16.38 tons of mixed office paper, 106.42 tons of newspapers and paperbacks, and 135.64 tons of cardboard, for a

total of 276.64 tons of recyclables. The drop-off Recycling Center at 1665 N. Fourth St., Breese, is open from 9 a.m. to 3 p.m. weekdays and employs adults with developmental disabilities.
